**DECREE MERGING THE PARISHES OF
SAINT CHARLES BORROMEIO, BRIDGEPORT, CT
and
SAINT GEORGE, BRIDGEPORT, CT**

In virtue of the office entrusted to me, I, the Most Reverend Frank J. Caggiano, Fifth Bishop of the Diocese of Bridgeport, duly concerned with the spiritual welfare of the souls entrusted to me, zealous of removing everything that may be detrimental to their well-being and desiring to promote everything becoming of their progress, having engaged with the people of Saint Charles Borromeo Parish, Bridgeport, CT and Saint George Parish, Bridgeport, CT, having prayerfully considered the information presented to me, the law and the facts, having heard all those whose rights may be harmed (c. 50), on February 24, 2023, having ascertained from documents and deeds and consulted those concerned that there are no major donors or heirs to be heard, and having heard the Council of Priests (c. 515 §2) on February 23, 2023, and having determined that the good of the souls requires it,

ESTABLISH THAT

The above two parishes be merged through an extinctive union so as to form one parish. This determination has been made to strengthen the pastoral care of the people of God in this area of my diocese, and to address several trends that are of serious concern, including; diminished Mass attendance, lack of sustainability in the face of diminishing income, declining sacramental celebrations, and clergy availability.

Wherefore, I, the undersigned Bishop of Bridgeport, in virtue of c. 515 §2 of the Code of Canon Law, do hereby decree that Saint Charles Borromeo Parish, Bridgeport, CT and Saint George Parish, Bridgeport, CT, which up until now have been independent parishes, be merged as to form one parish which will be named Saint Charles Borromeo Parish.

- I also hereby decree that all the rights, obligations and privileges of the members of Christian faithful domiciled in the territory of the now extinct Parish of Saint George, Bridgeport, CT, accorded to them by law or legitimately acquired, are to be transferred to and made part of Saint Charles Borromeo Parish.

PARISH NEWS

- The territorial boundaries of the aforementioned parishes by this canonical decree shall be amalgamated to become the boundaries of Saint Charles Borromeo Parish.
- Furthermore, the intentions of the founders and donors of the patrimony of Saint Charles Borromeo Parish, Bridgeport, CT and Saint George Parish, Bridgeport, CT, must be respected, in accordance with the law (c. 121 & 122).
- All sacramental registers, seals, and parish files of the parishes are to be properly transferred to, preserved and safeguarded by Saint Charles Borromeo Parish in accord with the norm of law.
- The Church of Saint George shall remain open as an additional worship site of Saint Charles Borromeo Parish.

This decree is effective on July 1, 2023.

This decree is to be communicated to the respective pastors who are the proper administrators of the two juridical persons that are being amalgamated. It is also to be communicated to all interested persons, according to the norm of law (c. 532). It may be challenged within the peremptory time limit of ten (10) days from the legitimate notification of the decree and in accordance with the norm of law (c. 1734 §2).

Given this day, the first of May, 2023, the Feast of Saint Joseph the Worker, at the Catholic Center, Bridgeport, Connecticut.

**DECRETO DE LA FUSIÓN DE LAS PARROQUIAS DE
SAN CARLOS BORROMEEO, BRIDGEPORT, CT
y
SAN JORGE, BRIDGEPORT, CT**

En virtud del cargo que me ha sido confiado, yo, el Reverendísimo Frank J. Caggiano, Quinto Obispo de la Diócesis de Bridgeport, debidamente interesado por el bienestar espiritual de las almas que me han sido confiadas, celoso de remover todo lo que pueda ser perjudicial para sus bienestar y deseo de promover todo lo que sea de su progreso, habiendo dialogado con los fieles de la Parroquia de San Carlos Borromeo, Bridgeport, CT y la Parroquia de San Jorge, Bridgeport, CT, habiendo considerado en oración la información que se me presentó, la ley y los hechos, oídos todos aquellos cuyos derechos pueden ser lesionados (c. 50), el 24 de febrero de 2023, habiendo comprobado por documentos y escrituras y consultado a los interesados que no hay mayores donantes o herederos a los que oír, y oído el Consejo de Sacerdotes (c. 515 §2) el 23 de febrero de 2023, y habiendo determinado que lo requiere el bien de las almas,

ESTABLEZCO QUE

Las dos parroquias anteriores se fusionen mediante una unión extintiva para formar una sola parroquia. Esta determinación se ha hecho para fortalecer el cuidado pastoral del pueblo de Dios en esta área de mi diócesis, y para abordar varias tendencias que son motivo de gran preocupación, entre ellas;

disminución de la asistencia a misa, falta de sostenibilidad frente a la disminución de los ingresos, la disminución de las celebraciones sacramentales y la disponibilidad del clero.

Por lo tanto, yo, el obispo de Bridgeport, suscrito, en virtud del c. 515 §2 del Código de Derecho Canónico, decreto por la presente que la Parroquia de San Carlos Borromeo, Bridgeport, CT y la Parroquia de San Jorge, Bridgeport, CT, que hasta ahora han sido parroquias independientes, se unan para formar una sola parroquia que será nombrada Parroquia de San Carlos Borromeo.

- También, por medio la presente, decreto que todos los derechos, obligaciones y privilegios de los miembros de los fieles domiciliados en el territorio de la ahora extinta Parroquia de SAN JORGE, Bridgeport, CT, otorgados a ellos por ley o legítimamente adquiridos, serán transferidos a y formarán parte de la Parroquia de San Carlos Borromeo.
- Los límites territoriales de las parroquias antes mencionadas por este decreto canónico se unirán para formar los nuevos límites de la Parroquia de San Carlos Borromeo.
- Además, las intenciones de los fundadores y donantes del patrimonio de la Parroquia de San Carlos Borromeo, Bridgeport, CT y la Parroquia de San Jorge, Bridgeport, CT, deben ser respetadas, de conformidad con la ley (c. 121 y 122).
- Todos los registros sacramentales, sellos y archivos parroquiales de las parroquias deben ser debidamente trasladados, conservados y custodiados por la Parroquia de San Carlos Borromeo de acuerdo con las normas de la ley.
- La Iglesia de San Jorge permanecerá abierta como un lugar de culto adicional de la Parroquia de San Carlos Borromeo.

Este decreto entra en vigor el 1 julio de 2023.

Este decreto ha de ser comunicado a los respectivos párrocos que son los administradores propios de las dos personas jurídicas que se amalgamarán. También debe comunicarse a todos los interesados, según la norma de la ley (c. 532). Puede ser impugnada dentro del plazo perentorio de diez (10) días desde

la notificación legítima del decreto y conforme a la norma de derecho (c. 1734 §2).
